#### Rationale

Conference participants will be encouraged to describe and analyse the challenges to empowerment of civil society in neighbourhood countries receiving EU aid, and to propose ways in which the EU could better empower local civil society and improve the role of EU-based NGOs as equitable partners in capacity development.

The conference should generate constructive debate between European development NGOs and think tanks and civil society organisations from Eastern Partnership countries and Central Asia about the ways in which the EU should improve and strengthen its support of the engagement of civil society in development and reforms in partner countries.

Recommendations developed by conference participants will be integrated in a policy brief on improving the impact of EU development aid on civil society development in receiving countries.
